

## **Purpose**

Under the Child Abuse Prevention and Treatment Act or CAPTA (Public Law 111-320), a referral of a child under the age of three who is involved in a substantiated case of abuse or neglect must be made to the early intervention program funded by Part C of the Individuals with Disabilities Education Act (IDEA). In Missouri, the Part C of IDEA is known as First Steps.

The Missouri Department of Social Services, Children's Division, requires staff refer to First Steps any child under age three who meets the criteria of CAPTA. This report provides information related to the number of First Steps infants referred through CAPTA in calendar year 2014.

## **Infants Enrolled in the First Steps Program**


In calendar year 2014, Children's Division reported 867 children were eligible for referral to the First Steps program pursuant to CAPTA requirements. Of the 867 children eligible, 208 (23.99%) were referred to First Steps with a referral reason of CAPTA. Additionally, there were 864 children referred to First Steps with a referral reason of Department of Social Services (DSS).

Of the 208 children referred through CAPTA, 31 (14.9%) were found eligible and reached the status of an Individualized Family Service Plan (IFSP). The remaining 177 children did not reach IFSP status due to the following reasons: 85 withdrawn by parent or guardian, 40 Part C ineligible, 38 unable to contact/locate, 7 refused by SPOE, and 7 inquiry only.

Of the 864 children referred by DSS, 168 (19.4%) were found eligible and reached the status of an Individualized Family Service Plan (IFSP). The remaining 697 children did not reach IFSP status due to the following reasons: 277 Part C ineligible, 273 withdrawn by a parent or guardian, 83 unable to contact/locate, 46 inquiry only, and 18 refused by SPOE.

## Average Age

Table 1 represents the average age at the time of enrollment in First Steps for the 208 children referred to First Steps for CAPTA, and the 864 children referred to First Steps by DSS. The average age for children enrolled in First Steps in 2014 was 14.4 months for CAPTA referrals and 15.4 months for DSS referrals.



## Active Children by SPOE Region

## Service Authorizations

Table 4 represents the First Steps service authorizations for the 31 children referred for CAPTA and received First Steps services. At the end of calendar year 2014, there were a total of 130 active authorizations for the 31 children referred for CAPTA.
