**SUMMARY**

This rule provided procedures and standards for approval of professional education programs in baccalaureate degree granting colleges and universities in Missouri. The rule also provided procedures and standards for approval of preliminary teacher education programs in associate's degree granting colleges in Missouri and acceptance of academic credits from these colleges for purposes of meeting requirements for teacher certification.

This rule is being rescinded because these requirements are contained within 5 CSR 20-400.440, Procedures and Standards for Approval and Accreditation of Professional Education Programs in Missouri.

Public comment was accepted from May 1, 2020, through May 31, 2020. During that time, there were no comments received.

**RECOMMENDATION**

The Department recommends that the State Board of Education authorize publication in the *Missouri Register* of an order of rulemaking to rescind 5 CSR 20-400.300, Procedures and Standards for Approval of Professional Education Programs in Missouri, and that the State Board finds the proposed rescission necessary to carry out the purposes of Sections 161.092, 168.021, 161.097, and 161.099, RSMo.

**ORDER OF RULEMAKING**

By the authority vested in the State Board of Education (board) under sections 161.092 and 168.021, RSMo Supp. 2005 and 161.097, and 161.099, RSMo 2000, the board rescinds the rule as follows:

**5 CSR 20-400.300** Procedures and Standards for Approval of Professional Education Programs in Missouri is **rescinded**.

A notice of proposed rulemaking containing the text of the proposed rescission was published in the Missouri Register on May 1, 2020 (45 MoReg 590). No Changes have been made in the text of the proposed rescission, so it is not reprinted here. This proposed rescission becomes effective thirty (30) days after publication in the *Code of State Regulations*.
