### **FFS = Fee-For-Service**

- Delivery of products will come once a month from the State of Missouri's contracted distributor along with monthly open order commodities.

### **NOI = Net-Off-Invoice**

- Commodity pounds diverted will be placed into either K-12 or Processor Link depending on the Processor and will be drawn down as pounds are used. If you choose NOI, then you will also need to choose a distributor. RA is invoiced directly from distributor at net price + distribution fees. The use of Hybrid Value Pass through Methods, such as Net off Invoice (NOI), may eliminate the need for storage costs. However, the RA will need to assess any increase in service and delivery fee a Distributor may require for this type of transaction to cover possible associated administrative costs. Additionally, note that the delivery fee is already included in the commercial price from which the value of DF is deducted.

### **Rebate**

- Pounds are diverted through the USDA Foods Packet. You will purchase desired processor's product from your chosen distributor, and after you purchase the product you will then send the processor the rebate form to receive the discount.
