Characteristics of New Proposal

3

- Allows for more instructional time
- Funds local access to formative/interim resources
 - grades 3-8 ELA and math
- Funds one NCAA compliant administration of the ACT[®]
 - to be bid
 - Each Missouri 11th grade student
- Maintains EOC assessments
 - Algebra I, Algebra II (for students taking Algebra I at middle level), English II, Biology, Government, and Personal Finance
- Produces valid, reliable, and quick MAP results
- Maintains Missouri Growth Model and federal compliance
- Maintains federal compliance

5th and 8th grade science

- Spring 2014 online field test
- Online version of our current grade-level science assessments
- Based on current GLEs and test designs
- Administration platform will be same as English language arts and mathematics
- 10 business day score turnaround

- 11th grade students
- ACT® with writing
- Accommodations will be available
- Valid administration for NCAA, scholarships, and admissions
- Single state administration date in March or April 2015
- Makeup date exactly 10 business days after the state administration date
- College and career ready measure

End-of-Course (EOC) Assessments

6

- Operational Summative Assessments for accountability purposes in 2014-2015 will be English II, Algebra I/Algebra II, Biology, and Government
- Personal Finance continues as is
- English I, Geometry, and American History will be available at district cost
- English language arts and mathematics EOCs will be updated to align to the Common Core expectations for the courses beginning with the Fall 2014 administration
- 5 business day score turnaround

3-8 English language arts and mathematics

- Online adaptive assessments
- 5th and 8th grade English language arts and mathematics assessments using the Smarter Balanced items, test design and blueprints
- 3rd, 4th, 6th, and 7th grade English language arts and mathematics survey assessments based on the Smarter Balanced test design and blueprints using the Smarter Balanced item banks.
- Unlimited access to English language arts and mathematics interim assessments for grades 3-8
 - Smarter Balance Summative blueprint – grades 3-8
 - Missouri Summative blueprint – grades 3, 4, 6, 7
