Mrs. Clark's Margarine

DESE – SFS budgets the amount of USDA Foods to send to each of the monthly processors based on the previous school year's consumption by MO LEAs. The amount of vegetable oil sent to Mrs. Clark's for school year 2011 – 2012 has quickly diminished and there will not be sufficient supplies to continue offering all of Mrs. Clark's products for the remainder of SY 11-12. The MC Margarine products were the largest consumers of vegetable oil by MO LEAs, so the decision has been made to discontinue the ordering of MC Margarine products with orders submitted in December. Any MC Margarine product ordered prior to November 15, 2011, (for January 2012 distribution) will be filled. MC Dressings and Sauces are expected to be available for the remainder of SY 11-12.

AdvancePierre Pork confusion in December

Initial information submitted to DESE – SFS by AdvancePierre for December 2011 distribution was incorrect. The problem was detected a couple days into December distribution, which prompted DESE – SFS to notify FDA and discontinue December distributions until a resolution was found. The correct information has been submitted to DESE – SFS and communicated to FDA; however December week 1 and week 2 have already been routed and will not contain any AdvancePierre pork items for LEAs expecting them. The December allocations will be made in January for LEAs in weeks 1 and 2. LEAs receiving shipments during weeks 3 and 4 should have no issues. We are very sorry about the confusion and inconvenience this has caused any of the LEAs.


There will only be three (3) Prorated Items for SY 11-12. The three items **will not** be sent to everyone, they will **only** be sent to the schools who elected to receive them via their Processing Packet for SY 11-12. The items are:

- **100158** – Ground Beef, Frozen, 4/10 lb
- **100098** – Chicken, 8 pc Cut-up
- **100258** – Apple Slices, Frozen, 30 lb

If your LEA received **100098** – *Chicken, 8 pc Cut-up*, in September, you can estimate to receive the same quantity in January. The **100158** – *Ground Beef*, can also be estimated to be the same quantities as were shipped in October and November. **If your LEA has received either 100098 or 100158 and would NOT like to receive additional product in January**, please email matthew.essner@dese.mo.gov. There are many LEAs who would like additional products and DESE – SFS does not want to burden your LEA with USDA Foods unusable in your operations.

Open Order Updates

1. USDA has had difficulty fulfilling potato orders for SY 11-12 and has shuffled MO orders around multiple times. Currently the **100355** – *Potato Wedges* are scheduled for April delivery, **100357** – *Oven Fries* are scheduled for February delivery, and **100358** – *Potato Rounds* are scheduled for March delivery. Hopefully this schedule will allow



USDA to get our trucks purchased so DESE – SFS can offer the items during the above mentioned months.

2. **100101** – *Diced Chicken* was originally scheduled for November delivery and was purchased by USDA; however there were payment issues between the vendor and USDA so the vendor was not shipping anymore USDA loads until they received payment. Initially DESE – SFS was told this would be resolved quickly and planned to ship **100101** in December, but the problem was still not resolved. USDA has now communicated that we should receive the trucks by the end of December.

DESE – SFS now plans to ship **100101** in January 2012. Once the trucks are received, the **100101** will be delivered based on the orders submitted to DESE – SFS back in October.

3. **100318** – *Mashed Sweet Potatoes* were expected for December delivery, but were not received as anticipated. The vendor plans to ship early in December and DESE – SFS plans to fulfill November requests on the January commodity deliveries.
4. As mentioned in the [October Commodity Shelf Newsletter](#), there was a bit of confusion with sliced (**100224**) and diced (**100225**) pears, and with the confusion, DESE – SFS neglected to post a value for the **100225** – *Diced Pears* which shipped in November. Both **100224** and **100225** had a value of \$ 23.80 per case.
