



# MoSPE – Standards for Ed Prep Programs

- 43 MO Institutions design their ~850 ed prep programs (EPPs) to meet these standards
- Current version (2013):
  - ❑ Academics
  - ❑ Program Design & Candidate Assessment
  - ❑ Field & Clinical Experiences
  - ❑ Candidate Characteristics
  - ❑ Faculty Characteristics



# MoSPE – Standards for Ed Prep Programs

- 2019: MoSPE Rewrite Team Revised EPP Standards (Current Version Still in Use)
- Jan.-Feb. 2020: Final Revision to be presented to Team, MABEP, Commissioner
- Mar 2020: Proposal of Revision to be made to Missouri School Board
- *Effective Date Dependent on Approval*

- Annual Scorecard
- 4 *Candidate-Level* Data Categories Collected, Compiled
  - ❑ MoCA - Content Assessments
  - ❑ GPA
  - ❑ MEES, MPEA - Performance Assessments
  - ❑ Surveys – 1<sup>st</sup>-Yr Teacher, Counselor, Principal
- 4 *Program-Level* Metrics to Calculate Score

  - ❑ School Leaders

- 2019/2020 Updates
  - ❑ MEES (Teachers) – 2019 rigorous content validation, revision, calibration, & *annual training for cooperating teachers, university supervisors, student teachers*
  - ❑ MEES (School Counselors) – content validation & calibration underway
  - ❑ MPEA (Building Leaders) – 2020 revision implemented
