On June 28, 2019, the United States Department of Agriculture (USDA) approved DESE-FNS's request to allow the implementation of a **5-year Administrative Review (AR) Cycle**. This 5-year cycle will also include a risk assessment to assess the need for more frequent visits depending on the results of your previous AR. More detail on the risk assessment will be released in the near future. A list of Local Education Agencies (LEAs) that are scheduled to receive an AR in the 2019-2020 school year can be found [here](#).

DESE-FNS hopes to use this extra time to increase program compliance, provide more technical assistance, create more resources and improve training across the state.

The Procurement Reviews will remain on their current 6-year cycle, with LEAs that have a Food Service Management Company (FSMC) receiving a procurement review once every three years.




# Food Buying Guide

On August 12, 2019, FNS released the Exhibit A Grains Tool as a new feature on the FBG Mobile App on both Apple and Google app stores! The Exhibit A Grains Tool was first released on the FBG Interactive Web-Based Tool to allow users to search their grain product (as listed on Exhibit A) and enter in the serving size as listed on the product label.

The tool then determines:

- the ounce equivalent (oz. eq) grains or grains/bread serving(s) for the grain product
- the amount of the grain product to serve to obtain a specific meal pattern contribution.
