

Policy Subcommittee

- ✧ **Goal 1 – Missouri will prepare, develop, and support effective educators through the implementation of rigorous educator preparation program approval standards to ensure recruitment, admissions/exit criteria, clinical practice experiences align to prepare career-ready educators capable of instructing all student populations using differentiated, evidence-based instructional practices and data-based decisions within a framework of multi-tiered systems of support.**

Policy Subcommittee

- ✧ **Goal 2 – Missouri will revise certification standards for teachers and educational leaders to ensure beginning and experienced educators are capable of teaching diverse learners in content and critical thinking skills to prepare them to successfully transition to post-secondary education, careers, and adult life.**

Educator Preparation

- ✧ **Goal 1 – Educator preparation programs will prepare pre-service educators and educational leaders to teach and lead in collaborative, learner-centered, inclusive schools using rigorous, relevant curricula and high-leverage, evidence-based instructional practices within a framework of increasing levels of academic and social-emotional-behavioral supports designed to positively impact the achievement and college-career-adult readiness for all learners.**
