DEPARTMENT GOAL NO. 3:

Missouri will prepare, develop, and support effective educators.

SUMMARY:

John H. Landes holds a lifetime certificate of license to teach in the area of Art, grades K–12. His certification is current and active.

On June 1, 2012, Mr. Landes pled guilty to one (1) count of the Felony, Driving While Intoxicated - Persistent Offender, committed on March 21, 2012 and two (2) counts of the Misdemeanor, Leaving the Scene of a Motor Vehicle Accident. Mr. Landes was sentenced to four (4) years' incarceration with the Department of Corrections for the felony and 30 days' in jail for the two (2) misdemeanors.

On June 1 2012, Mr. Landes pled guilty to one (1) count of the Felony, Driving While Intoxicated- Persistent Offender, committed on November 19, 2010. Mr. Landes was sentenced to four (4) years' incarceration with the Department of Corrections.

On June 1, 2012, Mr. Landes pled guilty to one (1) count of the Felony, Driving While Intoxicated - Persistent Offender, committed on March 10, 2012. Mr. Landes was sentenced to four (4) years' incarceration with the Department of Corrections.

Mr. Landes received notice of the hearing, but was neither present nor represented by counsel.

RECOMMENDATION:

It is recommended that the State Board of Education revoke Mr. Landes' teaching certification pursuant to its authority under Mo. Rev. Stat. § 168.071 (Supp. 2014).

Introduction

This matter was held on December 17, 2014, before Cynthia Quetsch, Hearing Officer, designated by the Commissioner of Education. Those present were:

Curtis Schube, Counsel for the Department of Elementary and Secondary Education;
Margery Tanner, Director of Educator Certification; and
Billie Jo Keim, Legal Assistant, Department of Elementary and Secondary Education

Findings of Fact

1. John H. Landes, Respondent, holds a lifetime certificate of license to teach in the area of Art, grades K–12 issued on February 1, 1978, which never expires. (Petitioner’s Exhibit 3) (Transcript page 7, line 9 to page 8, line 10).
2. On or about June 1, 2012, Respondent pled guilty to one (1) count of the Felony, Driving While Intoxicated, Persistent Offender, committed on March 21, 2012, in violation of Mo. Rev. Stat. § 577.010 and two (2) counts of the Misdemeanor, Leaving the Scene of a Motor Vehicle Accident in violation of Mo. Rev. Stat. § 577.060 in the circuit court of St. Louis County, Missouri. Respondent was sentenced to four (4) years’ incarceration with the Department of Corrections for the felony and 30 days’ in jail for the two (2) misdemeanors. (Petitioner’s Exhibit 4).
3. On or about June 1, 2012, Respondent pled guilty to one (1) count of the Felony, Driving While Intoxicated, Persistent Offender, committed on November 19, 2010, in violation of Mo. Rev. Stat. § 577.010 in the circuit court of St. Louis County, Missouri. Respondent was sentenced to four (4) years’ incarceration with the Department of Corrections. (Petitioner’s Exhibit 5).
4. On or about June 1, 2012, Respondent pled guilty to one (1) count of the Felony, Driving While Intoxicated, Persistent Offender, committed on March 10, 2012, in

violation of Mo. Rev. Stat. § 577.010 in the circuit court of St. Louis County, Missouri. Respondent was sentenced to four (4) years' incarceration with the Department of Corrections. (Petitioner's Exhibit 6).

5. On December 17, 2014, a hearing was held before Cynthia Quetsch, Hearing Officer. Respondent was not present and was not represented by counsel. Petitioner was represented by Assistant Attorney General Curtis Schube. (Transcript page 2, line 2 to page3, line 1).
6. Respondent received notice of the hearing by letter dated October 20, 2014, sent to the last known address of Respondent, both by certified mail and first-class mail. The certified mail was returned unclaimed. (Petitioner's Exhibits 1 and 2) (Transcript page 3, line 19 to page 6, line 11).

Conclusions of Law

1. Respondent was convicted of three (3) felony counts in circuit court in violation of Mo. Rev. Stat. § 577.010.
2. The charges concerning Respondent's current certificate were set for hearing and notice was served on the Respondent in compliance with the requirements of Mo. Rev. Stat. § 536.067 (Supp. 2014).
3. Mo. Rev. Stat. § 168.071.1 (1) (Supp. 2014) provides the following authority to the State Board of Education:


The state board of education may refuse to issue or renew a certificate, or may, upon hearing, discipline the holder of a certificate of license to teach for the following causes: (1) A certificate holder or applicant for a certificate has pleaded to or been found guilty of a felony or crime involving moral turpitude under the laws of this state, any other state, of the United States, or any other country, whether or not sentence is imposed;

4. Respondent pled guilty to three (3) felonies.
5. Based upon Mo. Rev. Stat. §168.071.1(1) (Supp. 2014) the State Board of Education is authorized to suspend or revoke any certificate held by Respondent.

Recommendation

It is recommended that the State Board of Education to revoke the certificate of license to teach of John H. Landes pursuant to its authority under Mo. Rev. Stat. § 168.071 (Supp. 2014).

1 PROCEEDINGS

2 MS. QUETSCH: This is the hearing in the
3 matter of Department of Elementary and Secondary Education
4 versus John Landes and has been designated Hearing 14-033.
5 This hearing is being held pursuant to Section 168.071 of
6 the Revised Statutes of Missouri, which authorizes the
7 State Board of Education to suspend or revoke a certificate
8 of license to teach if a certificate holder has pleaded to
9 or been found guilty of a felony or crime involving moral
10 turpitude under the laws of this state, or other any other
11 state, or in the United States, or any other country
12 whether or not sentence is imposed, or there is evidence of
13 incompetence, immorality, or neglect of duty by the
14 certificate holder.

15 Administrative rules adopted by the State
16 Board Education pursuant to the statute authorizes the
17 Commissioner of Education to designate a hearing officer in
18 these matters. My name is Cynthia Quetsch and I have been
19 designated to hear this case. Unless otherwise provided
20 under 168.071, this hearing is being pursuant to the
21 Procedural Rules of Chapter 563, the Administrative
22 Procedures Act.

23 The certificate holder, John Landes, is not
24 present at this hearing either personally or through
25 counsel. Assistant Attorney General Curtis Schube is

1 present on behalf of the state. Would you like to make an
2 opening statement?

3 MR. SCHUBE: I will make a short one. This
4 case is about a teacher, John H. Landes, who pled guilty to
5 four separate counts of driving while intoxicated,
6 persistent offenders and two separate counts of leaving the
7 scene of a motor vehicle accident. Before driving while
8 intoxicated persistent offender convictions for each felony
9 convictions, all four driving while intoxicated persistent
10 offender convictions and the two leaving the scene of an
11 accident convictions were crimes of moral turpitude.
12 Accordingly, Landes is subject to discipline of his three
13 teaching certificates pursuant to Section 168.071.1(1)
14 RSMo.

15 MS. QUETSCH: You may call your first witness.

16 MR. SCHUBE: I call Billie Keim.

17 BILLIE JO KEIM, having been first duly sworn, testifies as
18 follows:

19 Q Can you state your name and spell it for the
20 record, please?

21 A Billie Jo Keim; B-i-l-l-i-e, J-o, K-e-i-m.

22 Q And by whom are you employed?

23 A Missouri Department of Elementary and
24 Secondary Education.

25 Q And what is your position with the Department?

1 A Legal assistant.

2 Q What are your responsibilities as a legal
3 assistant?

4 A Some of my responsibilities include scheduling
5 disciplinary hearings, and notifying the appropriate
6 parties.

7 Q And when you schedule the hearings do you
8 serve the notice on them; is that correct?

9 A Yes.

10 Q And did you send such a notice to Mr. Landes,
11 the respondent?

12 A Yes.

13 Q And I previously handed you what's been marked
14 as Exhibit 1. Do you recognize that document?

15 A Yes.

16 Q What is it?

17 A This a letter of along with the complaint
18 notifying Mr. Landes of the hearing, the date, time, and
19 location of the hearing.

20 Q And to what address did you send the notice
21 to?

22 A 2229 Morconey Avenue, Apartment 2, St. Louis,
23 Missouri 63110.

24 Q And how did you get that address?

25 A This address came from the Attorney General's

1 office.

2 MR. SCHUBE: And just for the record I would
3 like to tell the hearing officer that I had contacted the
4 parole officer who gave me this address.

5 Q So did you -- first of all did you receive the
6 certificate back when you sent the certified mail to him?

7 A Yes, it came back unclaimed.

8 Q Okay. Did you also send it via first class
9 mail?

10 A Yes.

11 Q And did you receive that mail back?

12 A No.

13 Q Okay. Does that indicate to you that the
14 letter did get to him?

15 A Yes.

16 Q Okay. So Exhibit 1 is that a true and
17 accurate copy of the notice and complaint that you sent to
18 him?

19 A Yes.

20 Q And was this kept in your file in the regular
21 course of business?

22 A Yes.

23 Q And Exhibit 2, do you recognize that document?

24 A Yes.

25 Q What is it?

1 A It's a copy of the envelope from the certified
2 mail, this was returned unclaimed.

3 **Q Okay. Is that a true and accurate copy of**
4 **what you received back?**

5 A Yes.

6 **Q And does it give the same address that you had**
7 **on the letterhead that you had on the notice?**

8 A Yes.

9 **Q And again you did send two letters; is that**
10 **correct?**

11 A Yes.

12 MR. SCHUBE: Okay. I would like to offer
13 Exhibits 1 and 2.

14 MS. QUETSCH: They are received.

15 MR. SCHUBE: That's all I have for Ms. Keim.

16 MS. QUETSCH: Call your next witness.

17 MR. SCHUBE: I call Margery Tanner.

18 MARGERY TANNER, having been first duly sworn, testifies as
19 follows:

20 **Q Could you please state your name for the**
21 **record?**

22 A Margery Tanner.

23 **Q And, Ms. Tanner, by whom are you employed?**

24 A The Department of Elementary and Secondary
25 Education.

1 Q What is your position with the Department?

2 A I am the director for Educator Certification.

3 Q And what are your responsibilities in that
4 position?

5 A I license educators for the State of Missouri.

6 Q Do your duties include maintaining teacher
7 certification records?

8 A Yes.

9 Q I have put a packet of documents, one of which
10 is labeled as Exhibit 3, on your desk over there. Do you
11 recognize Exhibit 3 there?

12 A Yes, I do.

13 Q And what is it?

14 A This is a certification record for John
15 Landes.

16 Q All right. Is this a computer printout?

17 A Yes, it is.

18 Q And does the information in that computer kept
19 by the Department in the regular course of business?

20 A Yes, it is.

21 Q Is this a true and accurate copy of what the
22 computer would print out if you were to do that here today?

23 A Yes.

24 Q Now, according to this Exhibit 3 does
25 Mr. Landes hold any certificates?

1 A Yes, he does.

2 Q What certificate does he hold?

3 A He holds a lifetime teaching certificate for
4 the area of art grades K-12.

5 Q When was this certificate issued?

6 A February 1, 1978.

7 Q And is this certificate active today?

8 A Yes, it is.

9 Q And when will his certificate expire?

10 A It does not expire.

11 Q Now, does this record reflect whether
12 Mr. Landes is currently teaching anywhere in Missouri?

13 A No, it does not.

14 Q Does it indicate when the last time he would
15 have taught is?

16 A Well, the staff assignment report will reflect
17 back ten years and it shows that he has no district
18 reporting him for the past ten years.

19 MR. SCHUBE: Okay. I would like to offer
20 Exhibit 3.

21 MS. QUETSCH: It's received.

22 MR. SCHUBE: I have nothing further for
23 Ms. Tanner.

24 MS. QUETSCH: Anything else?

25 MR. SCHUBE: I would lake to also offer

1 Exhibits 4, 5, 6, and 7. These records establish
2 Mr. Landes for felony DWI persistent offender convictions
3 and the two leaving the scene of an accident conviction.
4 All of those crimes are crimes of moral turpitude, two of
5 them -- four of them are felonies and each of them
6 establish cause to discipline Mr. Landes' license.

7 MS. QUETSCH: And four is the court record,
8 I'm trying to distinguish them. We'll just say from
9 June 2012. And you're offering that?

10 MR. SCHUBE: Yes, sorry I would like to offer
11 them pursuant to Section 490 RSMo.

12 MS. QUETSCH: And five? What's the
13 difference?

14 MR. SCHUBE: There is four separate incidents
15 where he had DWI convictions so each of those are one of
16 those incidents. The leaving of the scene of the accident
17 and one of the DWI are 4, and then 5, 6, and 7 are each
18 their own individual DWI.

19 MS. QUETSCH: Okay. They are all received.

20 MR. SCHUBE: That's all the evidence that I
21 have.

22 MS. QUETSCH: Did you want to make a closing
23 statement?

24 MR. SCHUBE: I just ask that the Department of
25 Elementary and Secondary Education find cause to discipline

1 and impose the appropriate discipline.

2 MS. QUETSCH: Thank you. That will close the
3 record.







COMPLAINT

Petitioner, the Missouri Department of Elementary and Secondary Education ("DESE"), by and through counsel, the Attorney General for the state of Missouri, states for its cause of action:

- 1. DESE is an agency of the State of Missouri, created and established pursuant to § 161.020, RSMo,¹ for the purpose of administering and enforcing the provisions of Chapters 161 and 168, RSMo, governing public school personnel, including teachers and others.

¹All statutory citations are to the 2000 Missouri Revised Statutes as amended unless otherwise indicated.

2. Respondent, John H. Landes ("Landes"), currently holds a Missouri certificate of license to teach in the area of Art, grades K-12 ("Certificate").

3. Landes' Certificate is, and was, current and valid at all times the acts alleged herein occurred.

4. Jurisdiction and venue are proper before the Missouri State Board of Education (the "Board") pursuant to § 168.071, RSMo Cum. Supp. 2012, and 5 CSR 20-400.230.

5. Section 168.071, RSMo Cum. Supp. 2012, authorizes the Board to discipline a certificate and states, in pertinent part:

1. The state board of education may . . . upon hearing, discipline the holder of a certificate or license to teach for the following causes:

(1) A certificate holder or applicant for a certificate has pleaded to or been found guilty of a felony or crime involving moral turpitude under the laws of this state, any other state, of the United States, or any other country, whether or not sentence is imposed;

....

(3) There is evidence of incompetence, immorality, or neglect of duty by the certificate holder[.]

6. 5 CSR 20-400.230 states, in part:

(1) The State Board of Education (the board) may discipline, . . . a certificate of license to teach for any one (1) or combination of the following:

(A) An individual has pled guilty or been found guilty of a felony or crime involving moral turpitude whether or not sentence is imposed;

....

(C) Evidence of the certificate holder's incompetence, immorality, or neglect of duty;

....

(8) The board may suspend or revoke for a specified time, or indefinitely, a certificate of license to teach pursuant to the rules promulgated by the board.

7. Section 577.010, RSMo., states in pertinent part:

1. A person commits the crime of "driving while intoxicated" if he operates a motor vehicle while in an intoxicated or drugged condition.

8. Section 577.060, RSMo. states in pertinent part:

A person commits the crime of leaving the scene of a motor vehicle accident when being the operator or driver of a vehicle on the highway or on any publicly or privately owned parking lot or parking facility generally open for use by the public and knowing that an injury has been caused to a person or damage has been caused to property, due to his culpability or to accident, he leaves the place of the injury, damage or accident without stopping and giving his name, residence, including city and street number, motor vehicle number and driver's license number, if any, to the injured party or to a police officer, or if no police officer is in the vicinity, then to the nearest police station or judicial officer.

9. On or about June 1, 2012, Landes pleaded guilty to and was convicted of three separate counts of Driving While Intoxicated—Persistent Offender in violation of Section 577.010, RSMo. in the Circuit Court of St. Louis County, Missouri, Case Nos. 12SL-CR02781-01, 12SL-CR02637-01, and 11SL-CR05370-01.

10. As a result of Landes' pleas of guilty and conviction in Case Nos. 12SL-CR02781-01, 12SL-CR02637-01, and 11SL-CR05370-01, the court sentenced Landes to four years of incarceration.

11. On or about June 1, 2012, Landes pleaded guilty to and was convicted of Driving While Intoxicated—Persistent Offender and two separate counts of Leaving the Scene of a Motor Vehicle Accident in violation of Section 577.060, RSMo., Case No. 12SL-CR03302-01.

7. As a result of Landes' convictions in Case No. 12SL-CR003302-01, the court sentenced Landes to four years of incarceration.

8. In pleading guilty to four separate counts of Driving While Intoxicated—Persistent Offender and two separate counts of Leaving the Scene of a Motor Vehicle Accident, Landes was convicted of felonies and crimes of moral turpitude.

9. Landes' convictions for felonies and crimes of moral turpitude constitute cause to discipline his Certificate pursuant to § 168.071.1(1), RSMo Supp. 2012.

10. Landes' pleas of guilt to felonies and crimes of moral turpitude constitute cause to suspend or revoke his Certificate pursuant to 5 CSR 20-400.230(1)(A) and (8).


11. Landes' conduct in driving while intoxicated four times and in leaving the scene of a motor vehicle accident twice constitutes cause to discipline his Certificate pursuant to § 168.071.1(3), RSMo. Cum. Supp. 2012.

12. Landes' conduct in driving while intoxicated four times and in leaving the scene of a motor vehicle accident constitutes cause to suspend or revoke his Certificate pursuant to 5 CSR 20-400.230(1)(C) and (8).

13. Based upon the foregoing, Petitioner prays the Missouri State Board of Education to conduct a hearing pursuant to Chapter 168, RSMo, and thereafter issue its findings of fact and conclusions of law determining that Page's certificate to teach be disciplined and for such other and further relief as is deemed just and proper.
