Prior Direct Certification Process

- A list of eligible children based on their zip code was created and made available to Local Education Agencies (LEAs)
- This process was not efficient—it was a 43-step process
- An updated list of eligible children was made available to LEAs only 3 times per year-this list is still available if needed to compare to the current process

Current Process

- A Federal Grant was awarded to assist with meeting the new USDA Requirement of a 95% direct certification rate
- Goal is to improve the direct certification percentage by making the process less burdensome
- Eligibility has been incorporated into MOSIS
- Allows more targeted delivery of eligibility since districts request eligibility status versus referencing a list
- Students without a match must still complete the school meals application form if they or their family believe they are eligible for free meals

Using the Current Process

- Create a list of all students currently enrolled
- Upload file to the MOSIS Direct Certification Lookup
- Download Excel report listing eligible students in MOSIS
- Use report to directly certify the appropriate students and manually enroll the others
- Direct Certification Lookup is updated weekly! LEAs must run the report July, October and January each school year.

Item Name	Required	Definition
Collection Version	Required	Collection version should contain this value 'ALL1.0DirectCert'
State ID	Required	State assigned student identifier.
Local Student ID	Optional	Local student id maintained by the district. Allows for data to be associated to local systems from DESE source systems.
Last Name	Required	Legal last name.
First Name	Required	Legal first name.
Middle Name	Optional	Legal middle name.
Suffix	Optional	Legal name suffix. E.g. Jr, Sr
Date of Birth	Required	Date of birth.
SSN	Optional	Social Security Number. Formats allowed (999999999) or (999-99-9999)
Student Grade Level	Optional	Grade level as of the time data is being submitted unless otherwise specified.
Gender	Optional	Gender
Race	Optional	Pre-defined Race / Ethnic code.

Missouri Student Information System (MOSIS) – User's Agreement


