Why is the process being changed?

Missouri's current system is inefficient.

Missouri's current rate is 72%.

A new system will help ensure all eligible students have access to free school meals.

Nutrition is very important for academic achievement, as well as good health.

Current Direct Certification Process

- List of eligible children based on their zip code is created and made available to Local Education Agencies (LEAs)
- Current process is not efficient—it is a 43-step process
- Updated list of eligible children made available to LEAs only 3 times per year

New Process Overview

- Federal Grant was awarded to assist with meeting the new requirement of a 95% direct certification rate
- Goal is to improve the direct certification percentage by making the process less burdensome
- Eligibility has been incorporated into MOSIS
- Allows more targeted delivery of eligibility since districts request eligibility status versus referencing a list
- Students without a match must still complete the school meals application form if they or their family believe they are eligible for free meals

New Process

LEAs:

- Create a list of pre-school and school students currently enrolled in the National School Lunch Program.
- Upload list to the New MOSIS Direct Certification Lookup
- Retrieve Excel report listing eligible students in MOSIS
- Use list to directly certify the appropriate students and manually enroll the others
- New Direct Certification Lookup will be updated monthly! LEAs must run the report July, October and January each school year. However, recommend running report monthly. New Lookup file available the 10th of each month.

Item Name	Required	Definition
Collection Version	Required	Collection version should contain this value 'ALL1.0DirectCert'
State ID	Required	State assigned student identifier.
Local Student ID	Optional	Local student id maintained by the district. Allows for data to be associated to local systems from DESE source systems.
Last Name	Required	Legal last name.
First Name	Required	Legal first name.
Middle Name	Optional	Legal middle name.
Suffix	Optional	Legal name suffix. E.g. Jr, Sr
Date of Birth	Required	Date of birth.
SSN	Optional	Social Security Number. Formats allowed (999999999) or (999-99-9999)
Student Grade Level	Optional	Grade level as of the time data is being submitted unless otherwise specified.
Gender	Optional	Gender
Race	Optional	Pre-defined Race / Ethnic code.


