**DEPARTMENT GOAL NO. 4:**

The Missouri Department of Elementary and Secondary Education will improve departmental efficiency and operational effectiveness.

**SUMMARY:**

On January 14, 2014, the State Board of Education approved a notice of proposed rulemaking to amend 5 CSR 20-500.160, relating to order of selection of services. The notice of the proposed rulemaking was published in the March 3, 2014 edition of the *Missouri Register* for comment. No comments were received by Vocational Rehabilitation (VR) during the 30-day comment period. The proposed amendment relates to the order of selection for Vocational Rehabilitation (VR) services. It defines an individual with the most significant disability as being someone who is seriously limited in three (3) or more functional areas, and defines an individual with a significant disability as someone limited in one (1) or two (2) functional capacities in terms of employment outcome. The functional capacities are listed. Priority Category III includes all other eligible individuals with a disability. It also changes Division of Vocational Rehabilitation to the Office of Adult Learning and Rehabilitation Services.

**RECOMMENDATION:**

The Department recommends that the State Board of Education authorize publication in the *Missouri Register* of the order of rulemaking to amend 5 CSR 20-500.160, relating to the order of selection for services in the provision of VR services; and that the State Board finds this amendment necessary to carry out the purpose of Section 161.092, RSMo Supp. 2013 and Sections 178.600, 178.610, and 178.620, RSMo 2000.

**ORDER OF RULEMAKING**

By the authority vested in the State Board of Education under sections 178.600, 178.610, and 178.620, RSMo 2000 and section 161.092, RSMo Supp. 2013, the board amends a rule as follows:

**5 CSR 20-500.160 Order of Selection for Services is amended.**

A notice of proposed rulemaking containing the text of the proposed amendment was published in the *Missouri Register* on March 3, 2014 (39 MoReg 632-633). No changes have been made in the text of the proposed amendment, so it is not reprinted here. This proposed amendment becomes effective thirty (30) days after publication in the *Code of State Regulations*.
