The USDA Food Expos are an opportunity for food service directors (FSD)/head cooks to meet with DESE – Food and Nutrition Services (FNS) and learn more about the USDA Donated Foods (DF) Program offered in Missouri. The USDA Food Expos will be held **February 10-12, 2016**. Each USDA Food Expo will consist of three sessions:

1. Roundtable Discussions 2. Informational Meeting/Presentation 3. Food Show/USDA Foods Packet Help Session

Processors/Brokers are encouraged to take advantage of the Roundtable Discussions. Three discussions, 12-15 minute visits, are assigned to each attendee. Each Roundtable will have approximately 5-8 attendees (depending on # of sign-ups) and a processor/broker as the 'lead' of the discussion. **If you would like to lead a Roundtable discussion, sign up below so we can schedule attendees to meet with you.**

An opportunity to showcase/sample approved products will occur during the food show portion of the USDA Food Expo. ***ONLY APPROVED ITEMS AVAILABLE THROUGH DESE – FNS MAY BE SAMPLED DURING THE USDA FOOD EXPO.*** Processors will be allowed a *maximum* of one table per USDA Food item (beef, pork, chicken, cheese, turkey, etc.) Processors must provide their own chafing dishes, heat source (sternos), serving utensils, and any sampling supplies needed. If electricity is needed, please indicate below. Processors are allowed to hand out nutritional information, individual sheets of approved items, and business cards. **No POS/handouts are allowed** (examples: information about unapproved items, stuffed/squishy animals, key chains, pens, etc.) A contact for each location is listed below each USDA Food Expo site should you need to arrange sending materials in advance.

Registration is FREE, but required. Deadline is January 29, 2016.
