<b>SUMMARY</b>							
The attached resolution is to appoint the Communications Coordinator as the Custodian of Records for the Department of Elementary and Secondary Education, pursuant to Section 610.023.1, RSMo.							
By designating the Communications Coordinator as the Custodian of Records for the Department, rather than a named individual, it will establish continuity and avoid the necessity of passing a resolution each time a different individual holds the position.							
<b>RECOMMENDATION</b>							
The Department recommends that the State Board of Education adopt the resolution appointing the Communications Coordinator as the Custodian of Records for the Department.							

Resolution of the State Board of Education  
to Appoint the Communications Coordinator as Custodian of Records  
for the Department of Elementary and Secondary Education

WHEREAS, Section 610.023.1, RSMo, provides that a public governmental body is to appoint a Custodian of Records to maintain that body's records and the identity and location of the Custodian of Records is to be made available upon request.

NOW, THEREFORE, BE IT RESOLVED:

- 1) That the Missouri Department of Elementary and Secondary Education shall comply with Sections 610.010 to 610.030, RSMo, the Sunshine Law, as now existing or hereafter amended, and with its Department policy as now existing or hereafter amended; and
- 2) That the Missouri Department of Elementary and Secondary Education Communications Coordinator be and hereby is appointed Custodian of Records of the Missouri Department of Elementary and Secondary Education and that such Custodian of Records is located at the Jefferson State Office Building, 6<sup>th</sup> Floor, 205 Jefferson Street, Jefferson City, Missouri 65101.
