**STRATEGIC PRIORITY**

Teachers and Leaders – Prepare, develop and support educators to ensure an effective teacher in every classroom and an effective leader in every school.

**SUMMARY**

On June 14, 2018, the State Board of Education approved a notice of proposed rulemaking to amend Rule 5 CSR 20-400.510, Certification Requirements for Teacher of Early Childhood Education (Birth – Grade 3). The notice of proposed rulemaking was published for comment in *Missouri Register* on August 1, 2018.

The proposed amendment included revisions to literacy requirements to ensure sufficient training for educators so that effective reading diagnosis and instruction will be provided to all students.

The Department received one comment to the proposed rule. The comment was in favor of the proposed changes.

**RECOMMENDATION**

The Department recommends that the State Board of Education authorize publication in the *Missouri Register* of an order of rulemaking to amend Rule 5 CSR 20-400.510, Certification Requirements for Teacher of Early Childhood Education (Birth – Grade 3), and that the State Board finds these amendments necessary to carry out the purposes of Sections 161.092, 168.011, 168.021, 168.071, 168.081, 168.400, 168.405, and 168.409, RSMo.

**ORDER OF RULEMAKING**

By the authority vested in the State Board of Education (board) under Sections 161.092, 168.011, 168.021, 168.071, 168.081, 168.400, 168.405, and 168.409, RSMo, the board amends a rule as follows:

5 CSR 20-400.510 is amended.

A notice of proposed rulemaking containing the text of the proposed amendment was published in the *Missouri Register* on August 1, 2018 (43 MoReg 2014). The sections with changes are reprinted here. This proposed amendment becomes effective thirty (30) days after publication in the *Code of State Regulations*.

**SUMMARY OF COMMENTS:** The board received one (1) comment on this proposed amendment.

**COMMENT #1:** Steven Beldin on behalf of the Missouri Council of Administrators of Special Education (MO-CASE) suggested additional language be added to (1)(B)4.B.(I).

**RESPONSE AND EXPLANATION OF CHANGE:** Based upon the comment received, amended section to (1)(B)4.B.(I). to include explicit and systematic instruction.
