DEPARTMENT GOAL NO. 1:

All Missouri students will graduate college and career ready.

SUMMARY:

On May17, 2016, the State Board of Education approved a notice of proposed rulemaking to rescind Rule 5 CSR 20-200.110, Relating to Standards and Operational Requirements until these statutes were repealed in 2012 with House Bill 1608. This rule established the policies and standards to assist any district in establishing before- and after-school child care programs for school-age children who are enrolled in the district and who are between the ages of 5 and 14 years. A district may establish such a program directly or through contract with any not-for-profit corporation. This notice of proposed rulemaking was published in the *Missouri Register* on July 1, 2016 (41 MoReg 832-833). No written comments were received during the thirty (30) day time period which ended on July 31, 2016.

RECOMMENDATION:

The Department recommends that the State Board of Education authorize publication in the *Missouri Register* of an order of rulemaking to rescind Rule 5 CSR 20-200.110, Relating to Standards and Operational Requirements, and that the State Board finds this rescission necessary to carry out the purpose of Sections 167.290-167.296 and 167.300-167.310, and 167.298, RSMo.

ORDER OF RULEMAKING

By the authority vested in the State Board of Education (board) under sections 167.290-167.296 and 167.300-167.310, RSMo (1994) and 167.298, RSMo (Cum. Supp. 1996), the board rescinds a rule as follows:

5 CSR 20-200.110 Standards and Operational Requirements is rescinded.

A notice of proposed rulemaking containing the text of the proposed rescission was published in the *Missouri Register* on July 1, 2016 (41 MoReg 832-833). No changes have been made in the text of the proposed rescission, so it is not reprinted here. This proposed rescission becomes effective thirty (30) days after publication in the *Code of State Regulations*.

SUMMARY OF COMMENTS: The State Board of Education (board) received no comments on the proposed rescission.
