---

- “Goal is to finalize CTE strategic plan in alignment with workforce development”-Brian Noller
- 18 participants in survey- 13 council members, and five DESE staff members.
- Compared survey results to Priority Action Step Matrix. Examine rank of action steps within each priority.
- Determine “action teams” to implement the goals, objectives, and improvement actions within each of the strategic priority focus areas. These teams will “develop quality programs, look at data, develop staffing and focus on staffing of those programs.”-Brian Noller

#### **Talent for Tomorrow Update- Rob Dixon, Zora Mulligan, Mardy Leathers**

---

- Update since kickoff in April
  - Zora Mulligan – “Since then the three of us have been around the state twice, or three times to talk with people in regions about the issues they’re facing in terms of workforce development”
  - Coordination between the regions and the state for particular degree levels.
- Workforce Development
  - Future workforce- take a comprehensive look.
  - Economic comparison of Missouri to other states
    - Rob Dixon- Dead last in GDP development, near the bottom in workforce productivity, wage growth, etc.
    - Rob Dixon “Key to unlocking that is a sophisticated approach to workforce development and education. Specifically... we need more people in our workforce... get people off sidelines and make them more productive.”
    - Rob Dixon “you cannot have a successful economic development strategy, without a successful talent in the workforce strategy.”

- Proposed FY2020 High Demand Occupations List
  - High Demand list for Enhancement Grant funding
  - Collaboration with Workforce Development and Talent for Tomorrow to determine list
  - Goal is to push money into these high demand occupations
  - Focus on sustainability
