Council members identified gaps and provided advice on methods to close such gaps as related to establishing guidelines and requirements for the Career and Technical Education (CTE) Certificate.

Math/Communication/Workplace skills (Department of Education /Department of Economic Development)
Workkeys/ACT (legislation has been introduced giving kids the option) either one or both.
Softskills, CTSO participation
Curriculum-Create list similar to workplace learning

It was recommended that we add to the certificate requirement

7. Softskills/business skill attainment as measured by:

- a. Active participation in a Career Technical Student Organization (CTSO) with a score of three (3) or above on the CTSO June Core Data file during their junior or senior year, or
- b. Score at an advanced level or 90% or above on a district-developed or adopted softskills/ethics assessment during the junior and/or senior year, or
- c. A minimum of three letters of recommendation from at least three different business partners not related to the student who assure the student has a high level of soft-skill efficacy and is career ready, or
- d. A score at or above the state standard on any department-approved measure(s) of college and career readiness, for example, the ACT, SAT, ACT-WorkKeys, or Armed Services Vocational Aptitude Battery as determined in the most current MSIP Performance Standards.
