

## MPP Function Codes

(Revenue Code: 5382)

### Professional Development

#### **2200 – Professional Development.** (LEA’s teachers, assistants and directors)

- 6100 Certificated Salaries - stipends paid to Certified Staff for professional development (PD) occurring outside the regular contract period and/or substitute pay for PD attended during regular contract period
- 6150 Noncertificated Salaries - stipends paid to Noncertified Staff for professional development occurring outside the regular contract period and/or substitute pay for PD attended during regular contract period
- 6200 Employee Benefits – benefits associated with the stipends for Certified and Noncertified staff and substitutes used for teacher and/or teacher assistant’s PD attendance
- 6300 Purchased Services –conference fees, travel and lodging. Services rendered by persons not employed by the program, such as consultants, their travel and reasonable related expenses. Also includes fees for accreditation, curriculum training, professional memberships such as NAEYC and T.E.A.C.H. scholarships
- 6400 Materials & Supplies – resource books or professional journals related to Early Childhood

### Community Set Aside

#### **3000 – Community Services.** Professional development services for licensed providers who provide care to age eligible children

- 6300 Purchased Services – Professional Development Opportunities for program staff such as conference fees, travel and lodging. Services rendered by persons not employed by the program, such as consultants, their travel and reasonable related expenses. Fees for accreditation, curriculum training, early childhood conferences/seminars and T.E.A.C.H. scholarships
- 6400 Materials & Supplies – resource books associated with curriculum training

### Parents as Teachers

#### **3511 – Parents as Teachers.** Activities providing programs for Parents as Teachers outside of the regular classroom setting, including screening, personal visits and/or group meetings

- 6300 Purchased Services – Funds requested under this code cannot exceed the current PAT reimbursement rate and must be for the services provided above and beyond the state reimbursed services

### Classroom & Playground Instruction

#### **3512 – Early Childhood Instruction.** Learning experiences in a classroom setting

- 6100 Certificated Salaries and substitute pay for absences not related to professional development
- 6150 Noncertificated Salaries and substitute pay for absences not related to professional development
- 6200 Employee Benefits
- 6300 Purchased Services – educational field trips, lease payments for classroom space
- 6400 Materials & Supplies – items consumed in nature, have a useful life of less than two years, cost less than \$1,000 per unit and are more feasibly replaced than repaired. Refer to the Basic Materials and Supplies List
- 6500 Capital Outlay – Classroom equipment items that have a useful life of more than two years, cost more than \$1,000 per unit and are more feasibly repaired than replaced

### Remodeling of MPP Space

#### **4000 – Facility Acquisition and Construction.** Expenditures for maintaining the MPP space. Please note that these expenditures should be prorated if the same space is being used by non MPP funded children.

- 6300 Purchased Services – contracting services for remodeling or maintenance of the physical space or playground
- 6400 Materials & Supplies – Items used to remodel and maintain the physical space or playground that cost under \$1,000.
- 6500 Capital Outlay – Items used to remodel and maintain the physical space or playground that cost over \$1,000.
