Letters from the Missouri Ethics Commission requesting board member information will be sent to charter schools in the next few days. The actual filing is due by May 1, 2014.

Attached are several items for your consideration:

- A draft of 5 CSR 20-100.265, charter school closure, that was approved by the State Board and has been forwarded to the Secretary of State's office. While additional changes might be made (usually punctuation/grammar), we think it will be reviewed by JCAR and published in the *Missouri Register* in the next month. We appreciate all the help from the sponsors in writing this rule.
- A letter to CSP grant recipients. We have a total of six CSP grants this year, three new grants and three continuing grants. Attached is the information that we will post on our website. Negotiations for the new grants are underway. The US DOE is considering our request for a no-cost extension. If an extension is granted, we hope to quickly publicize it.
- A charter school sponsor evaluation schedule outlining our three-year evaluation plan. This begins our three-year cycle of evaluation/renewal. The order is (mostly) based on the year sponsorship was received.
- The charter sponsor evaluation application and charter sponsor evaluation rubric. Again, our thanks to all of you who participated in the mock-evaluations and for all the great suggestions for making this a more useful process both for the sponsors and the state. My personal thanks to all of you who have assisted me with this for the last seven months!

Finally, the Office of College and Career Readiness, posted an administrative memo on the new assessment plan that will modify the grades and subject areas tested.
