ORDER NUMBER 4

On September 13, 2012, in Order Number 3, among other things, this Chairperson set the issues for hearing in this matter as follows:

Issue 1: Whether the District provided Student a free, appropriate public education, as that term is defined by IDEA, and Missouri law implementing IDEA, between December 2009, and December 30, 2010?

Issue 2: Whether the District's placements and proposed placement for Student between December 2009, and December 30, 2010, were in the least restrictive environment, as that term is defined by IDEA, and Missouri law implementing IDEA.

Issue 3: Whether Petitioners failed to comply with any procedural requirements of IDEA, or Missouri law implementing IDEA, between December 2009, and December 30, 2010, that limit the relief available to them under IDEA, and Missouri law implementing IDEA.

Issue 4: What if any relief are Petitioners entitled to under IDEA, and Missouri law implementing IDEA?

On or about September 18, 2012, Petitioners provided a notice of dismissal with prejudice to the Respondent, which has been forwarded to this Chairperson.


In accordance with the terms of the agreement among the parties, these issues remaining for hearing and all respective claims within these issues, are dismissed with prejudice.
