Initial claims for payment must be submitted within 60 days from the date the service was delivered. To ensure payment on the Check Run Date, please submit all claims between the Claim Submission Period for the applicable check run listed. Please do not wait until the last day of the period to submit claims, as we cannot guarantee processing if there are technical difficulties.

The Check Run Date is a proposed date and does not guarantee that payments will be made that day. Payments may be sent up to 3-5 business days after the Check Run Date.
