CURRICULUM TRAINING REIMBURSEMENT

INSTRUCTIONS

The Department of Elementary and Secondary Education (DESE), Home Visiting Section will reimburse school districts for each new parent educator that meets the following requirements: connected to the district's Company Profile with Parents as Teachers National Center (PATNC), completed the PATNC Foundational (FND) and Foundational 2 (FND2) curriculum trainings, and completed the Family Visit Consultation (FVC). DESE will reimburse \$1,000 per parent educator that fulfills the requirements outlined above. All requirements must be met prior to submitting the reimbursement request.

- 1. Connect the parent educator to the district's Company Profile, register, pay, and complete both the FND and FND2 curriculum trainings with PATNC.
- 2. Complete an FVC with your assigned consultant. If a consultant has not contacted you within 45 days of completing FND training you may contact Diane Addison with the Missouri Parent Education Program Support at daddison@missouripat.org.
- 3. Complete this form and submit along with your paid curriculum training invoices to DESE (the paid invoice will indicate an amount paid and a zero balance due). To access the paid invoice in the PATNC portal, follow these steps:
 - The parent educator that created the order will log into the PAT E-business portalClick on the "My Profile" icon (upper righthand corner)
 - Click on "View/Pay Orders"
 - Click on the order link

- · Use the PDF menu in the preview window to print or save the invoice
- 4. Once the information is received and verified, DESE will process your request for reimbursement. Reimbursement requests will be processed on a first-come, first-served basis as long as funds are available.
