Nine Days Left to Test: Pull the test monitoring report to verify blueprint coverage. If science is required, all nine testlets should be given.

Field Testlets: After a student completes the blueprint requirements in a subject, the student may receive a field test testlet. Field tests are critical to the production of high-quality operational assessments. Teachers administer field tests to evaluate item quality for the assessed linkage levels of Essential Elements. Items must be field-tested before being included in the operational testlet pool. Field test testlets are available for most linkage levels and Essential Elements. A field test testlet will be delivered at the same linkage level, one level above, or one level below the level at which the student took their operational testlets for the Essential Element. Field-test testlets are in Kite® Student Portal, and students sign in using their credentials like operational testlets. Field tests are found in each subject-specific tab. Field test results do not impact Individual Student Score Reports. Participation is strongly encouraged to build the pool of available testlets for all students—but not required.

MDTC Corner

Pull Test Monitoring Data Extract: Go to Dynamic Learning Maps.org, Educator Portal, then Reports. Select Data Extracts, then the Test Administration and Monitoring tab. Find the extract called "DLM Instructionally Embedded Monitoring." Click New File. Select DLM assessment program. If necessary, select the district (leave school as select). Leave the default dates. Click Ok. If another dialogue box opens that says the file will be deleted and do you wish to continue, click Yes. The CSV icon will be replaced with "in queue." When the words change back to the icon, click on it to open the newly pulled extract spreadsheet. Column K indicates the percent of Blueprint coverage for ELA (the goal is 100%). Column R indicates the percent of Blueprint coverage for math (the goal is 100%). Column Y indicates the number of science testlets completed (the goal is 9). The NA in Column Y indicates that student is not rostered in science.

Student Transfer within the District: Logon to Educator Portal. Click Settings. Choose Students. Click Transfer Students tab. Complete the district and school boxes for the current district and building. Click Search. Click the box in the row with the student to transfer. Click Next (lower right corner). Leave most boxes as default. Choose Exit Reason, Code One. Complete the Destination Attendance School box. Click Next (lower right corner). Click Next. Click Next. Click Yes.

Clean Data: Please clean your data now. Make sure students' names are correct and in the correct fields. Check the MOSIS numbers, grade level and birth date for accuracy.
